

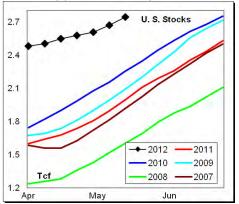

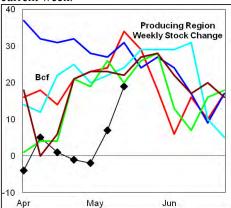

Summary ¹ The stock build of +77 Bcf for the week was a record low build for the 4th consecutive week. *The average build for this time of year is* +100 Bcf.



Heating degree days for the week ending 19May12 were -49% below normal and forecast to be -69% below normal for the current week.



In the East Region stocks increased +45 Bcf for the week, a build slightly below the 5-year range. Stocks increased +13 Bcf in the West Region, a build that matched the 5-year midrange. The stock build of +19 Bcf in the Producing Region was near the historic low for this time of year.

Heating degree days were -48% below normal in the East Region, -54% below normal in the West Region and -53% below normal in the Producing Region for the week ending 19May12.

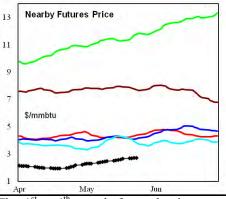

forecast to be -75% below normal for the current week.

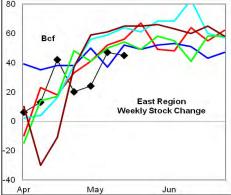
The 6-10 day NWS forecast for the week ending 02Jun12 is for warmer than normal temperatures in the southwest 1/2 of the country and normal elsewhere.

The 8-14 day NWS forecast for the week ending 06Jun12 is for warmer than normal temperatures in the southwest 1/2 of the country and near normal elsewhere. Prices: Nearby gas futures prices increased +\$0.13/mmbtu for the week ending 24May12. The current price is -\$0.94/mmbtu below the prior 5-year low for this time of year.



The 1st – 4th month forward price curve trended higher for the week ending 24May12 (declining carry), ending at a level which matched last years' high.

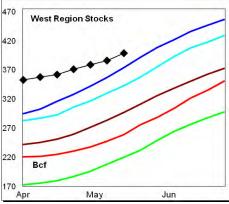
East Region stocks increased +45 Bcf for the week, a build below the historic range for the week. The current stock level was +52% above last year, and above prior 5-year highs.



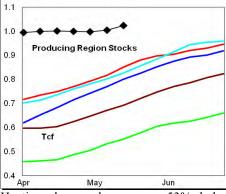
Heating degree days in the region were -48% below normal for the week ending 19May12, and forecast to be -75% below normal for the current week. Temperatures are forecast to be near normal in the region for the next 10-days. West Region stocks increased +13 Bcf on the week, a build that matched the 5-year midrange. Stock levels ended the week

+54% above last year and above the 5-year range. The latest 4-wk stock build was at the low end of the historic range.

Heating degree days were -54% below normal for the week ending 19May12, and forecast to be -44% below normal for the current week. Temperatures are forecast to warmer than normal for the next 10-days.



Producing Region stocks experienced a build of +19 Bcf on the week, a build near the historic low for the period. Unusually warm temperatures, substitution of gas for coal electric power generation and shut in of wells has prevented normal seasonal stock builds. Stock levels ended the week +19% above last year.



Heating degree days were -53% below normal for the week ending 19May12, and forecast to be -65% below normal for the current week. Above normal temperatures are forecast for the next 10-days.

Residual Fuel Oil Switching: The price spread between fuel oil and natural gas remains highly favorable for gas, with residual fuel demand -30% below last year. Outlook: Gas substitution for coal to generate electricity, unusually warm temperatures and shut in of wells due to low prices have limited seasonal stock building. Look for strength in gas prices to continue.

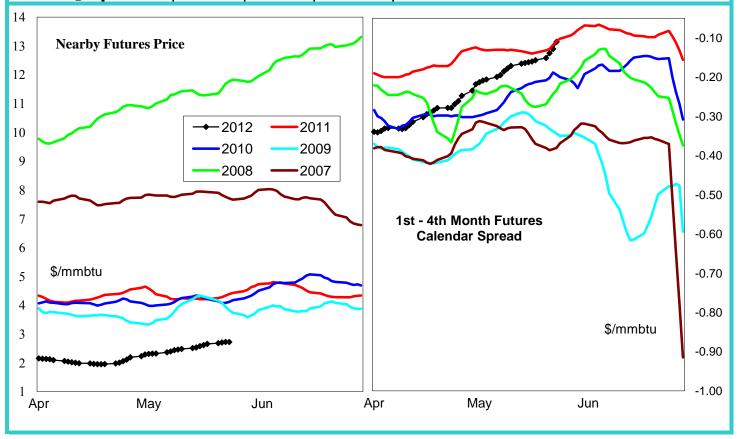

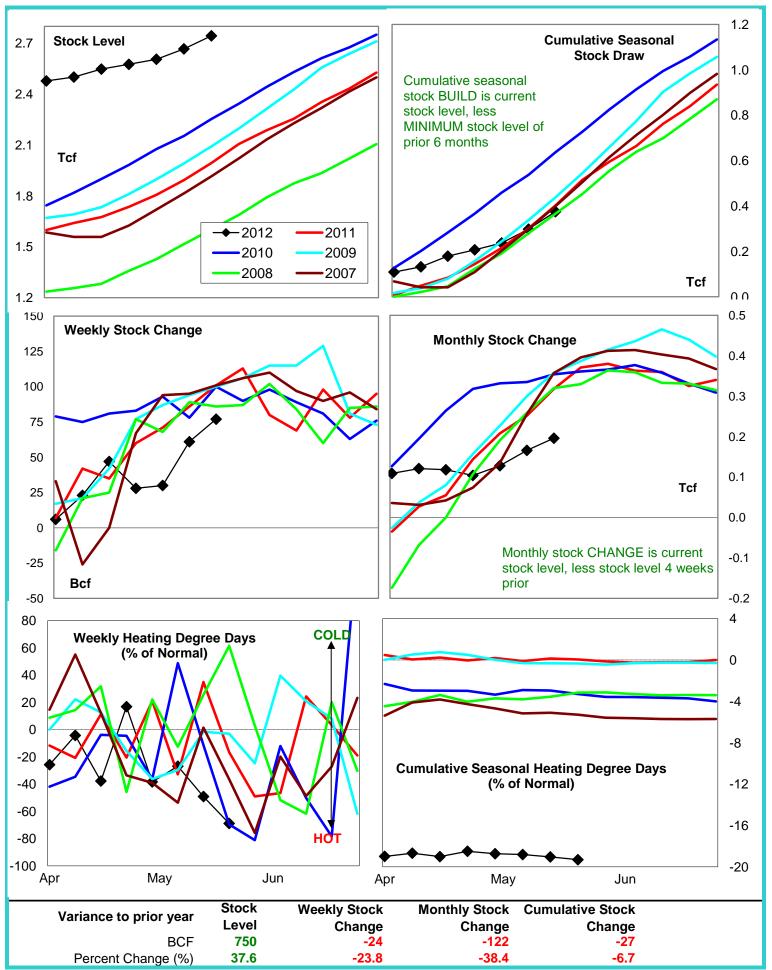

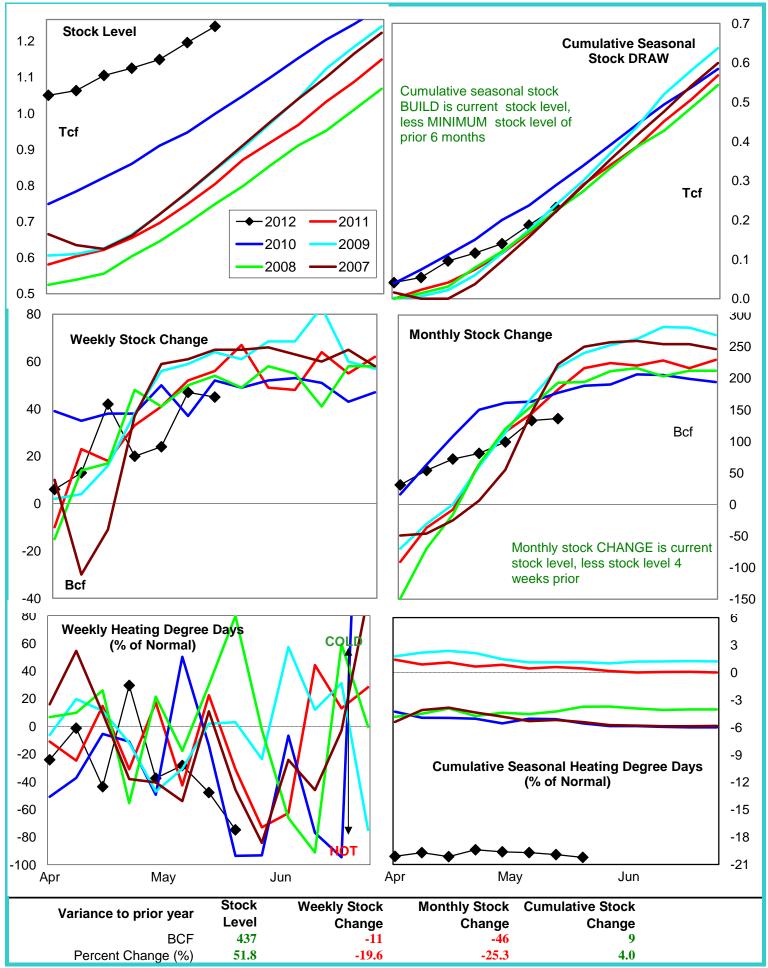

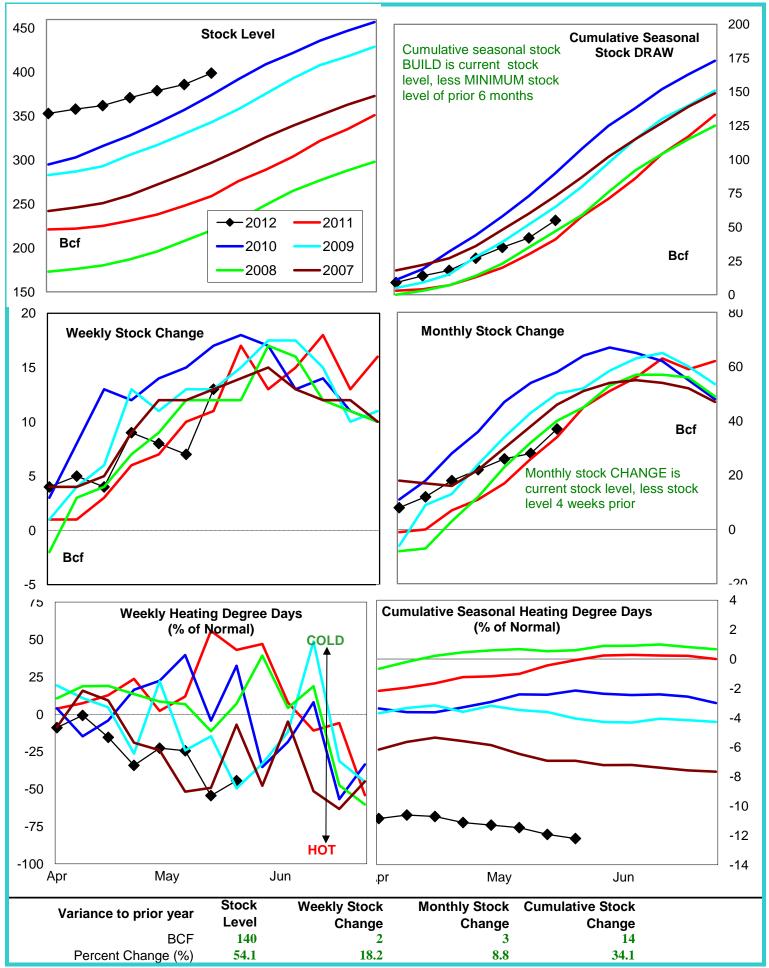
United States Natural Gas Stock and Weather Trends



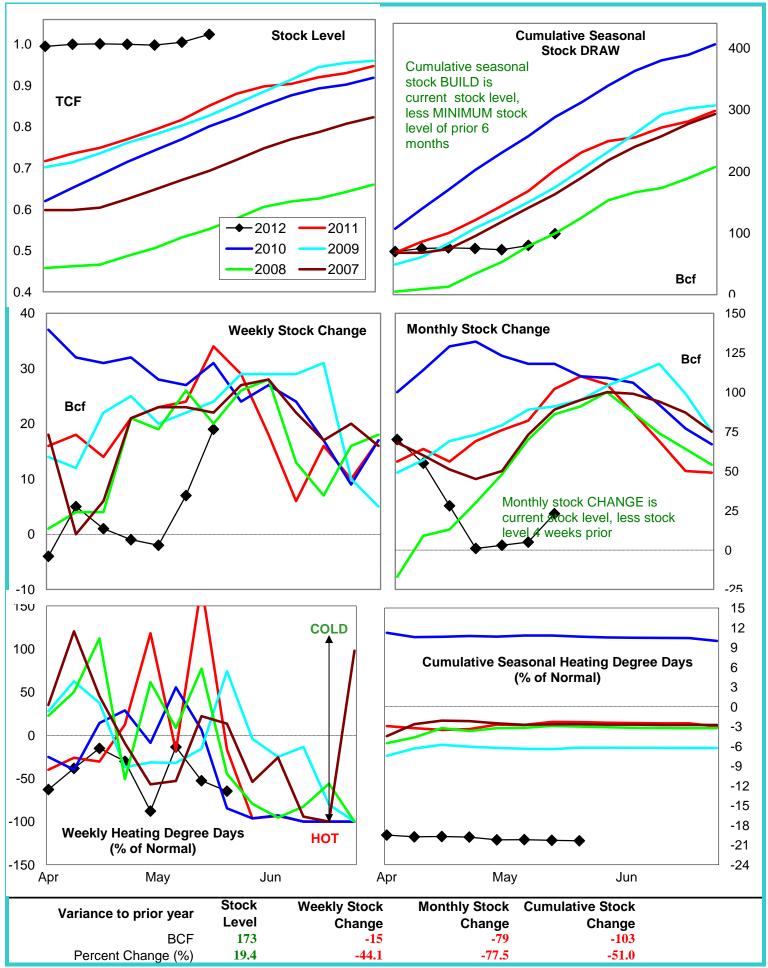
Natural Gas East Region Stock and Weather Trends



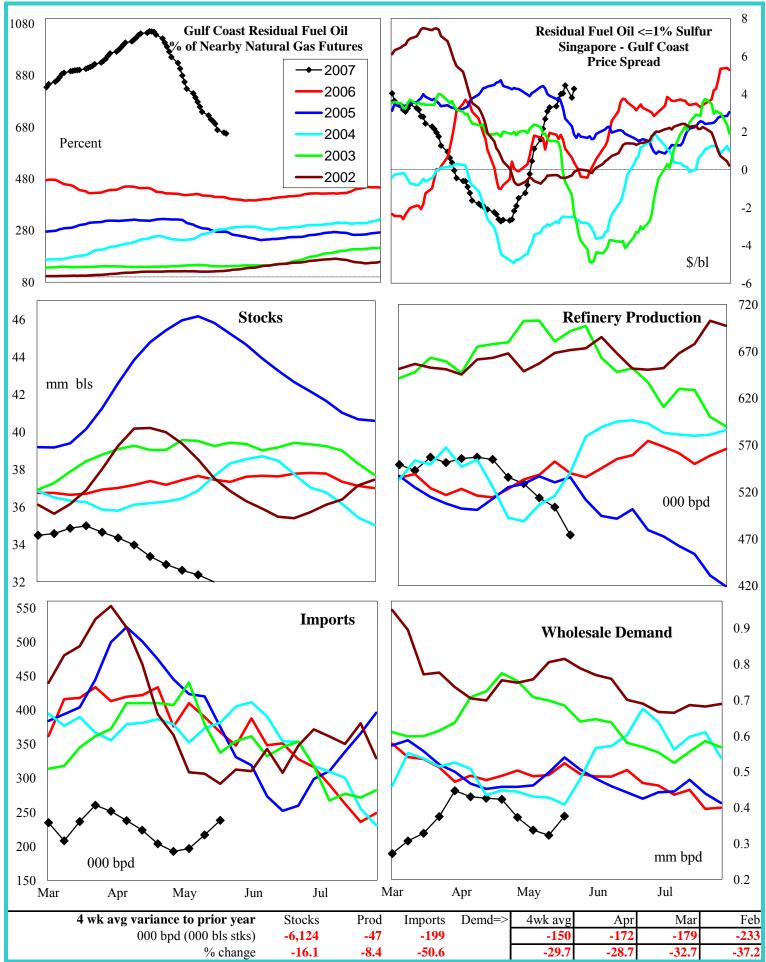
Natural Gas West Region Stock and Weather Trends



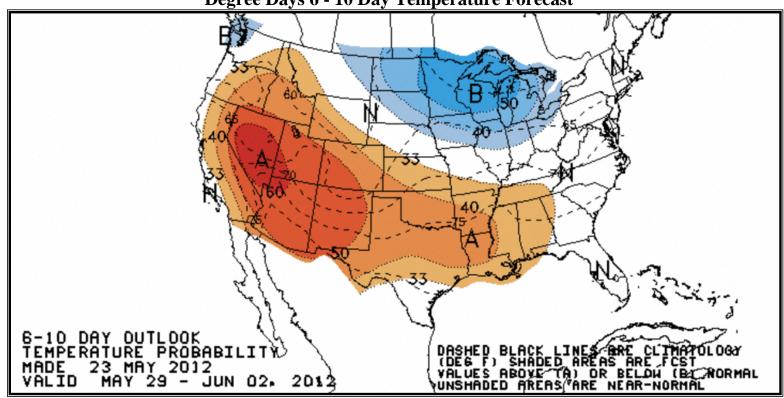
Natural Gas Producing Region Stock and Weather Trends



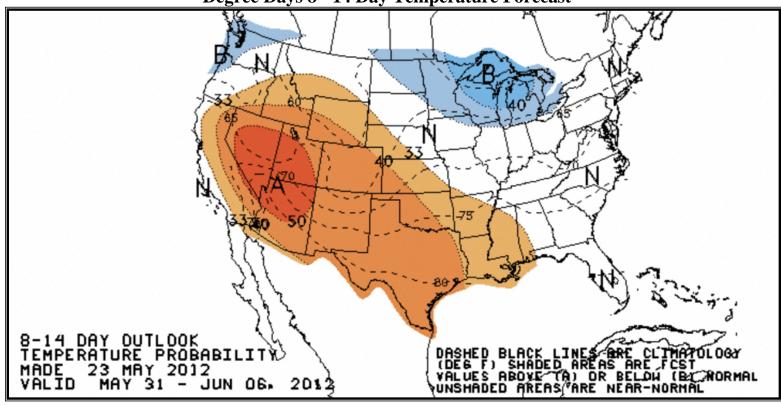
U.S. Residual Fuel Oil Price Spreads and Supply Balance
